This mobile application can download a fraudulent mobile application of the Bank.

The Bank hereby declares that the Bank did not have any connection with this mobile application. This mobile application is not established by the Bank. Please do not download, browse or log-in this mobile application.

The Bank suggests customers to take appropriate measures for ensuring relevant mobile application of the Bank is visited. Customer should search "Wing Lung Bank" at App Store or Google Play or go to Wing Lung Bank's website (<a href="www.winglungbank.com">www.winglungbank.com</a>) to download the Bank's official "WLB Wintech mobile application".

The Bank has reported the fraudulent mobile application to the relevant regulator(s) and the Hong Kong Police Force.
