

一周股市動向



受到新型冠狀病毒疫情影響,美國 3 月非農職位減少 70.1 萬個,遠差於市場預期的減少 10 萬個,為 2010 年以來最差,美股上周五受壓,道指中段反覆滑落逾 500 點,失守 21,000 關,三大指數的跌幅都超過 2%。上周三,滙豐控股(00005)應英倫銀行要求凍結派息和普通股回購,股價持續弱勢,全周累插 16.5%為表現最差藍籌。人行上周五收市後宣布對中小銀行定向降準,定向下調存款準備金率 1 個百分點,分別 4 月 15 日和 5 月 15 日實施,每次下調 0.5 個百分點,共釋放長期資金約人民幣 4,000億元。另一方面,石油出口國組織與盟友(OPEC+)推遲原定周一的電話會議時間,市場關注雙方可能無法達成減產協議,國際油價周一亞洲時段急挫逾 10%。港股上周回軟,恒指上周五收報 23,236 點,跌 43 點,一周累跌 248 點,短期料於現水平整固。



- 《金融時報》報道·美國銀行於周一向聯儲局提交年度壓力測試所須的資本計劃時·將歇力維護其股息政策不變。報道引述消息人士稱·歐洲監管機構因應新冠病毒肆虐情況·要求當地金融機構停止派息或減少派息的行動·令到美國銀行感受很大壓力。歐洲央行3月27日指令區內銀行·10月前不可派發股息與回購股份·以確保有充足資金應對疫情的經濟衝擊。
