

一周股市動向



美國股市上周在聯儲局「放鴿」的消息下先升後跌,美股上周五先升後回,道指早段一度升 837 點,及後轉跌 49 點,最終升 477 點,報 25,605 點;標普 500 指數升 39 點,報 3,041 點;納指升 96 點,報 9,588 點。回顧上周,標準普爾 500 指數在周四急挫近 6%,而周五則反彈 1%,但整周跌幅則是 3 月以來最差。牽動大市由升轉跌的是聯儲局上周三的議息會,雖然聯儲局維持基準利率不變,但顯示利率在 2022 年前也不大可能上升。另外,近日新冠肺炎疫情出現第二波爆發,美股期貨在亞洲時段大幅下滑。市場本周焦點是周二公布的美國 5 月零售銷貨值,有關數據將反映美國民眾的消費情緒有否好轉。美國零售銷貨值 4 月跌 16.7%,但市場預期 5 月數值將有所上升。聯儲局主席鮑威爾將於周二與周三出席國會參眾兩院委員會聽證會,發表對經濟前景的看法,顯然也是重要指標。


- 中國 5 月居民消費價格指數(CPI)按年上漲 2.4%、漲幅連續四個月回落。國家統計局新聞發言人付凌暉表示,內地 5 月主要經濟指標繼續改善,但不少仍低於去年同期水平,從累計看,多數指標仍在下降,表明新冠疫情衝擊損失尚需彌補,經濟還未回歸正常水平。
- 國家統計局公布·今年首 5 月·商品房銷售額 4.63 萬億元(人民幣·下同)·按年下跌 10.6%·降幅比首 4 個月收窄 8 個百分點·其中·住宅銷售額跌 8.4%· 辦公樓銷售額跌 35.3%·商業營業用房銷售額跌 26.6%。
