


一周股市動向

2020年08月31日



美國 8 月消費者信心指數終值為 74.1·高於市場預期的 72.8·反映消費者信心好轉,數據帶動美股造好。上周美股及港股靠隱,全星期道指升 723 點,報 28,653 點;標普 500 指數升 110 點,報 3,508 點;納指升 383 點,報 11,695 點。恒指全周升 308 點,報 25,422 點。費城聯儲銀行總裁哈克(Patrick Harker)接受 CNBC 訪問表示,看到美國通脹復甦勢頭,但進展較緩慢。2700萬美國人仍然失業,而且額外失業救濟金限期在 8 月過後,消費開支預料將出現明顯下滑,相信就業市場需要一段時間才能從新冠肺炎疫情的衝擊中復原,回復至疫情前水平。美國聯儲局主席鮑威爾在上周四,提出可能維持低息的言論,或繼續對股市有刺激作用。本周市場繼續關注中美關係,以及將於周五公布的美國非農就業報告。近星期恒指處於橫行階段,於 25,000-26,000點徘徊,受制於 250 天線約 25,780 點。


- 中國製造業活動持續處於擴張水平,但表現遜預期。 國家統計局公布,8月份,中國製造業採購經理指數 (PMI)略為回落至51,較上月略降0.1個百分點,遜 於市場預期的51.2。
- 穆迪發表報告稱,將中國房地產板塊的展望調整至「穩定」,因應開發商的合同銷售恢復緩慢增長、庫存保持穩定水平,以及國內及離岸的融資渠道對財務 狀況良好的房企保持暢通。
