


一周股市動向

2020年09月07日



美國 8 月失業率較 7 月回落 1.8 個百分點,至 8.4%,比預期的 9.8%為佳。全星期道指跌 520 點,報 28,133 點;標普 500 指數跌 81 點,報 3,426 點;納指跌 382 點,報 11,313 點。恒指全周跌 726 點,報 24,695 點。據外電報道,日本軟銀成立以科技為主的投資基金後,上月底大舉掃入以 10 億美元計、包括期權在內的股票衍生工具,為已十分熾熱的多隻科技龍頭火上加油。一些投機衍生工具的對沖基金也感到十分緊張,認為軟銀是這次波動市的納斯特巨鯨(Nasdaq whale),只是一味看好,為市場帶來極大風險。美國聯邦儲備局主席鮑威爾表示,8 月非農業職位增幅良好,但央行將保持高度量化寬鬆措施,以支持經濟增長。

鮑威爾接受美國媒體訪問時稱·雖然 8 月非農業職位增長數據良好·但往後的就業數據可能變差·相信經濟可能在一段「長時間」內·仍然須要聯儲局的超低利率政策支持。他提到的「長時間」·是以年計算。


