

一周股市動向



上周美股三大指數輕微上升,納指更升 3%。美國電動車生產商特斯拉(Tesla)本周一正式晉身標指之前,上周五股價創下紀錄新高,尾段出現大幅波動,且成交激增。另外,美國共和黨籍國會參議院多數黨領袖麥康奈爾表示,共和民主兩黨領袖已經達成新紓困計劃,涉及金額為 9,000 億美元,預計將於本周一進行表決。歐洲方面,市場擔心英國和歐盟最終無法達成脫歐貿易協議。另外,英國出現變種新冠病毒,當地疫情急劇惡化,新增確診創單日新高,累計確診人數突破 200 萬。德國、法國、意大利、荷蘭、比利時及奧地利,禁止來自英國航班降落,其他歐洲多國亦正考慮對英國入境旅客設限。由於全球疫情急劇惡化,或影響舊經濟股份表現。港股方面,恒指仍未走出 26,000-27,000 點窄幅波動的困局,本周港股只有三日半交易日,假期氣氛濃厚,市場關注新冠疫情及中美關係發展,新經濟龍頭續受市場關注,展望恒指於聖誕節前夕平穩上落。
