## Part 1 - CMB Wing Lung Private Banking Service Charges

Charge Item	Charge Scale
Monthly Maintenance Fee	CMB Wing Lung Private Banking Service is offered to customers free of charge as long as the Total Relationship Balance* reaches HKD30,000,000. Otherwise, a Monthly Maintenance Fee of HKD4,000 will be charged in the following month.

### Notes:

\* “Total Relationship Balance” means the average balance of the immediate preceding three months of the accounts / products (including demand deposits, fixed deposits, gold, securities and wealth management) of the customer portfolio.

- The closing prices of gold, securities holdings and wealth management on every trade day are used to calculate the average balance of previous three months.
- The balance of credit card account, utilized overdraft facilities of current account and utilized margin loan of securities margin account are excluded in calculating the Total Relationship Balance.

1. "Each calendar year" means from 1<sup>st</sup> January to 31<sup>st</sup> December each year. For 2017, it will be calculated from 1<sup>st</sup> April to 31<sup>st</sup> December 2017. The charge will be directly debited from customer's relevant account(s) in January of the following year.
2. The following customers are exempted from service charge on Paper Statement by Mail :
  - Aged 65 or above (applicable to one of joint account holder) ;
  - Aged below 18 ;
  - Account holder being Recipients of Government Disability Allowance or Comprehensive Social Security Assistance.
3. Personal customers who already registered e-Statement Services and apply for Reprint Statement Request via NET Banking Services can enjoy a fee waiver for the first 6th statement reprints (only applicable to statements within 7 years) annually. The statement reprints cover deposits accounts (including All-In-One Card Account, statement savings account and current account) dated August 2019 or before.

4. *New corporate customer means the corporate customer who does not maintain any account(s) with the Bank under the same account name on or before 31<sup>st</sup> March 2016.*
5. *“Multiple Layers Company” means a company which is not directly and wholly held by a natural person.*
6. *For ATM Cash withdrawal (including deposit accounts linked to a credit card) :*
- *For ATM transactions settled in HKD and routed through the “UnionPay” Network, if the transaction is in the local currency, the withdrawal amount is converted to HKD at the daily exchange rate set by UnionPay.*
  - *For ATM transactions settled in HKD and routed through the “JETCO” Network, if the transaction currency is in RMB, the money withdrawn is converted to HKD at the daily exchange rate set by JETCO member banks. If the transaction currency is in MOP, the withdrawal amount is converted to HKD at the daily exchange rate set by JETCO.*
  - *For ATM transactions settled in HKD and routed through the “MASTERCARD CIRRUS” Network, if the transaction is in the local currency, the money withdrawn is first converted to USD and then to HKD at the daily exchange rate set by Mastercard.*
  - *For oversea ATM transactions, which settled in HKD and routed through the “VISA PLUS” Network, if the transaction is in the local currency, the withdrawal amount is converted to HKD at the daily exchange rate set by Visa plus 1% conversion charge.*
  - *Surcharges of overseas local bank may be levied (if applicable).*
7. *Deposit account(s) without any transactions for 2 consecutive years will be treated as “Dormant Account(s)”. Customer may visit any branches of the Bank for reactivation of respective “Dormant Account(s)”.*
