This is a fraudulent website.

The Bank and Wing Lung Insurance hereby declare that the Bank and Wing Lung Insurance do not have any connection with this website. This website is not established by the Bank or Wing Lung Insurance. Please do not log-in or browse this website.

The Bank and Wing Lung Insurance suggest customers to take appropriate measures for ensuring relevant websites of the Bank are visited. Customers should insert the official websites of the Bank to the browser namely [www.winglungbank.com](http://www.winglungbank.com) and “www.winglungsec.com” of Wing Lung NET Securities.

The Bank and Wing Lung Insurance have reported the fraudulent website to the relevant regulator(s) and the Hong Kong Police Force.
