## REPORT OF THE DIRECTORS

董事會同人現謹向各股東發表截至二〇〇五年十 二月三十一日止年度之報告書及已審核之賬目。 The directors have pleasure in presenting their report together with the audited accounts for the year ended 31 December 2005.

## 主要業務

本行及其附屬公司之主要業務為銀行及有關之 金融服務。附屬公司之業務見賬目註釋(二十 八)。

本集團是年度按業務及地域劃分之表現分析詳 載於賬目註釋(四十)。

## 業績及分配

本集團是年度之溢利連同有關溢利分配說明列於本年賬目第三十九頁之綜合損益表內。

董事會已宣派中期股息每股普通股港幣五角七仙,並於二〇〇五年九月二十八日派發,總額 為港幣一億三千二百三十四萬八千元。董事會 建議派發末期股息每股普通股港幣二元一角三 仙,總額為港幣四億九千四百五十六萬五千元。

### 儲備

本集團及本行儲備之變動詳載於賬目註釋(三十 八)。

按照香港《公司條例》第七十九B條計算,本行 於二○○五年十二月三十一日之可分配儲備總 額為港幣七十五億零六百八十八萬八千元。

### 捐款

是年度本集團之慈善捐款共為港幣二十六萬九 千元。

## 董事

本屆及截至本報告書日期止之董事芳名,詳載 於本年報第四頁。

董事伍步謙博士、伍步揚先生及梁乃鵬博士照本行註冊章程第一百條, 例應告退, 但均願應 選連任。

## **Principal activities**

The Bank and its subsidiaries are engaged in the provision of banking and related financial services. The principal activities of the subsidiaries are set out in note 28 to the accounts.

An analysis of the Group's performance for the year by business and geographical segment is set out in note 40 to the accounts.

## **Results and appropriations**

The results of the Group for the year ended 31 December 2005 are set out in the consolidated profit and loss account on page 39 together with particulars of the appropriations therefrom which have been made or which are recommended.

The directors have declared an interim dividend of HK\$0.57 per ordinary share, totalling HK\$132,348,000, which was paid on 28 September 2005. The directors recommend the payment of a final dividend of HK\$2.13 per ordinary share, totalling HK\$494,565,000.

### Reserves

Details of the movements in the Group's and the Bank's reserves are set out in note 38 to the accounts.

Distributable reserves of the Bank at 31 December 2005, calculated under section 79B of the Hong Kong Companies Ordinance, amounted to HK\$7,506,888,000.

## **Donations**

Charitable and other donations made by the Group during the year amounted to HK\$269,000.

#### **Fixed assets**

Details of the movements in the Group's and the Bank's fixed assets are set out in note 31 to the accounts.

#### **Directors**

The directors during the year and up to the date of this report are listed on page 4.

In accordance with Article 100 of the Bank's Articles of Association, Dr Philip Po-him WU, Mr Ivan Po-young WU, Dr Norman Nai-pang LEUNG retire by rotation at the forthcoming Annual General Meeting, and, being eligible, offer themselves for re-election.

此外,是年度內及至是年終結日止,本行或其 附屬公司並無訂立任何與本行業務有關而董事 直接或間接享有重大權益之其他重要合約。 All the interests stated above represent long positions. No short positions were recorded in the register maintained under section 352 of the Hong Kong Securities and Futures Ordinance as at 31 December 2005.

None of the directors have been granted, or have exercised, any rights to subscribe for shares of the Bank.

At no time during the year was the Bank or its subsidiaries a party to any arrangement to enable the directors and chief executive of the Bank to hold any interests or short positions in the shares in, or debentures of, the Bank or its associated corporations.

### **Directors' interests in contracts**

The Bank rents from Wings Investment Company Limited certain office space in Wings Building under two tenancy agreements, for terms of three years commencing January 2005 and six years commencing December 2002, at rentals based on independent professional valuations. Dr Michael Po-ko WU, Dr Patrick Po-kong WU, Mr Albert Po-cheung WU, Dr Philip Po-him WU, Mr Anthony Shang-fung WU and Ms Alice Shang-sze WU (Alternate to Mr Albert Po-cheung WU) are directly or indirectly interested in Wings Investment Company Limited as shareholders.

No other contracts of significance in relation to the Bank's business to which the Bank or its subsidiaries was a party and in which a director of the Bank had a material interest, whether directly or indirectly, subsisted at the end of the year or at any time during the year.

The percentage of the Group's income for the year attributable to the five largest customers of the Group is less than 30%.

### **Public float**

Based on the information that is publicly available to the Bank and within the knowledge of the Directors, it is confirmed that there is sufficient public float of more than 25% of the Bank's issued shares at the latest practicable date prior to the issue of the annual report.

### Financial disclosures

The Bank has fully complied with the requirements set out in the guideline entitled "Financial Disclosure by Locally Incorporated Authorised Institutions" issued by the Monetary Authority in November 2002.

### **Auditors**

The accounts have been audited by PricewaterhouseCoopers who retire and, being eligible, offer themselves for re-appointment.
