REPORT OF THE DIRECTORS

董事會同人現謹向各股東發表截至二○○四年十二月三十一日止年度之報告書及已審核之賬目。

The directors have pleasure in presenting their report together with the audited accounts for the year ended 31 December 2004.

主要業務

本行及其附屬公司之主要業務為銀行及有關之 財務服務。附屬公司之業務見賬目註釋(二十 一)。

本集團是年度按業務及地域劃分之表現分析詳 載於賬目註釋(三十二)。

業績及分配

本集團是年度之溢利連同有關溢利分配說明列 於本年賬目第三十頁之綜合損益表內。

董事會已宣派中期股息每股普通股港幣四角八仙,並於二〇〇四年九月二十七日派發,總額為港幣一億一千一百四十五萬一千元。董事會建議派發末期股息每股普通股港幣一元九角八仙,總額為港幣四億五千九百七十三萬七千元。

儲備

本集團及本行儲備之變動詳載於賬目註釋(三十)。

按照香港《公司條例》第七十九B條計算,本行於二〇〇四年十二月三十一日之可分配儲備總額為港幣五十七億一百零七萬四千元。

捐款

是年度本集團之慈善捐款共為港幣一十三萬七 千元。

固定資產

本集團及本行固定資產之變動詳載於賬目註釋 (二十四)。

董事

Principal activities

The Bank and its subsidiaries are engaged in the provision of banking and related financial services. The principal activities of the subsidiaries are set out in note 21 to the accounts.

An analysis of the Group's performance for the year by business and geographical segment is set out in note 32 to the accounts.

Results and appropriations

The results of the Group for the year ended 31 December 2004 are set out in the consolidated profit and loss account on page 30 together with particulars of the appropriations therefrom which have been made or which are recommended.

The directors have declared an interim dividend of HK\$0.48 per ordinary share, totalling HK\$111,451,000, which was paid on 27 September 2004. The directors recommend the payment of a final dividend of HK\$1.98 per ordinary share, totalling HK\$459,737,000.

Reserves

Details of the movements in the Group's and the Bank's reserves are set out in note 30 to the accounts.

Distributable reserves of the Bank at 31 December 2004, calculated under section 79B of the Hong Kong Companies Ordinance, amounted to HK\$5,701,074,000.

Donations

Charitable and other donations made by the Group during the year amounted to HK\$137,000.

Fixed assets

Details of the movements in the Group's and the Bank's fixed assets are set out in note 24 to the accounts.

Directors

The directors during the year and up to the date of this report are listed on page 4.

Mr Kee-choe NG does not offer himself for re-election; Mr Che-shum CHUNG, Dr Michael Po-ko WU and Dr Patrick Po-kong WU, being eligible, offer themselves for re-election.

None of the directors proposed for re-election at the forthcoming Annual General Meeting has a service contract with the Bank which is not determinable by the Bank within one year without payment of compensation (other than statutory compensation).

Non-executive directors are subject to retirement by rotation and re-election at the Annual General Meeting in accordance with the Articles of Association of the Bank.

Substantial shareholders

At 31 December 2004, the register of substantial shareholders maintained under section 336 of the Hong Kong Securities and Futures Ordinance showed that the Bank had been notified of the following substantial shareholders' interests, being 5% or more of the Bank's issued share capital:

At no time during the year was the Bank or its subsidiaries a party to any arrangement to enable the directors and chief executive of the Bank to hold any interests or short positions in the shares in, or debentures of, the Bank or its associated corporations.

Directors' interests in contracts

The Bank rents from Wings Investment Company Limited certain office space in Wings Building under two tenancy agreements, for terms of three years commencing January 2002 and six years commencing December 2002, at rentals based on independent professional valuations. Dr Michael Po-ko WU, Dr Patrick Po-kong WU, Dr Jieh-yee WU, Mr Albert Po-cheung WU, Dr Philip Po-him WU and Mr Stephen Tze-tung HO were directly or indirectly interested in Wings Investment Company Limited as shareholders during the year.

核數師

本賬目經由羅兵咸永道會計師事務所審核,該 核數師亦照章告退,但願意應聘續任。

Purchase, sale or redemption of shares

The Bank has not redeemed any of its shares during the year. Neither the Bank nor any of its subsidiaries has purchased or sold any of the Bank's shares during the year.

Management contracts

No contracts concerning the management and administration of the whole or any substantial part of the business of the Bank were entered into or existed during the year.

Major customers

The percentage of the Group's income for the year attributable to the five largest customers of the Group is less than 30%.

Code for securities transactions by directors

The Bank has adopted a code of securities transactions by directors (the "Code of Conduct") on terms no less exacting than the required standard of the Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") as set out in Appendix 10 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

Following specific enquiry made with all directors, the Bank has confirmed that each of the directors complied with the required standard set out in the Model Code and the Code of Conduct regarding securities transactions by the directors.

Financial disclosures

The Bank has fully complied with the requirements set out in the guideline entitled "Financial Disclosure by Locally Incorporated Authorised Institutions" issued by the Monetary Authority in November 2002.

Auditors

The accounts have been audited by PricewaterhouseCoopers who retire and, being eligible, offer themselves for re-appointment.
